

#### **449 Issuance of site compliance certificate to fire safety requirements**

It is issued upon request of concerned person in relation to the requirements of another legislative act (e.g. specific rules of the bodies of the state and local authorities, issued under Article 137, Paragraph 2, of the Ministry of Interior Act).

- Certificate
- Economic activity:
  - Fire and explosive activity
- Based on:
  - the Ministry of Interior Act - Art. 125, para. 1, item 10
  - Ordinance No. 8121h-882 dated 25.11.2014 on the Procedure for Implementation of State Fire Control - Art. 33, para. 1, item 5
- Body, issuing an individual administrative act:
  - The Director of the Fire Safety and Civil Protection General Directorate or the Director of the Regional Directorates of Fire Safety and Civil Protection
- Period of issuance:
  - 14 days
- Period of validity of the document/individual administrative act:
  - 3 years
- Authority exercising control over the activity of the service provider:

- Order, including time limits for appealing the actions of the service provider:
  - The certificate can be issued both by the General Fire Safety and Civil Protection Directorate and by the Regional Directorates of Fire Safety and Civil Protection, depending on the specifics of the site.

Refusal to issue a certificate may be contested by administrative order before the higher administrative authority, through the administrative body that issued it, within 14 days of its notification under the procedure of the APC.

  1. A copy of a power of attorney (contract) – when the applicant is different from the owner of the site;

2. for legal entities registered abroad - original or copy of a registration document (judgment or other certificate according to the laws of the state of registration of the legal entity);

3. document for paid state fee under Tariff № 4 on the fees collected in the system of the Ministry of Interior under the State Fees Act, SG No. 27 of 1998;

4. a copy of a use permit, a certificate of putting into operation or a certificate of tolerance.

The check is on the eligibility of the request and the completeness of the attached documents

#### **Verification of the merits**

It includes a substantive examination of the attached documents, as well as certification check for which a record is drawn up.

In the protocol the conformity of the object is established by:

1. the legislative acts applicable to the construction upon putting it into operation, or the requirements of the construction and technical regulations and fire safety norms in force at the time of the inspection;

2. fire safety rules and standards for the operation of the sites in force at the time of the inspection.

Based on the results of the protocol check, the conformity or non-compliance of the site with the requirements of the fire safety rules and regulations is assessed as follows:

1. the site complies with the requirements of the fire safety rules and standards - there is full compliance with its actual status with fire safety rules and standards and conditions for their observance have been established;

2. the site does not comply with the requirements of the fire safety rules and regulations - there is non-compliance with the rules and fire safety regulations or no conditions for their observance

### **Issuing / refusal to issue a certificate**

Based on the certification audit protocol, the director of the General Fire Safety and Civil Protection Directorate, respectively the director of the Regional Directorate of Fire Safety and Civil Protection, issues or refuses the issue a certificate.

#### **988 Issuance of permit for carrying out activities for ensuring fire safety of sites and/or maintenance and service of fire safety tools, systems and equipment**

The services is provided upon request by traders willing to carry out fire safety activities; firefighting activity; rescue activity; service of fire tools; maintenance of fire systems and equipment

The following documents should be attached to the application:

1. Unified identification code (UIC), when registered under the Commercial Law or a copy of a certificate for entry into the relevant register under the national law of the respective Member State, in a legalized translation into Bulgarian.
2. List of the owned or hired equipment as well as equipment under para. 4 and documents proving the ownership or legal basis for its use.
3. Criminal record or similar document under the national legislation of another state for the trader's representative stating that he/she have not been convicted of an intentional offense of general nature.
4. An official document issued by a judicial authority or a relevant document under the national law of another country proving that there is no criminal proceedings against the representative of the trader for an intentional crime of a general nature.
5. A medical certificate by a medical center or a similar document under the national legislation of another country, certifying that the trader's representative does not suffer from mental disorders.

6. A list of the employees and their respective positions and duties.
7. List of addresses of workshops where the maintenance of firefighting tools will be carried out and of mobile workshops – plate number of the vehicles.
8. Documents proving professional qualification, documents under points 3 – 5, as well as a copy of the contract – for each employee.
9. A medical certificate by a medical center or a similar document under the national legislation of another country certifying that the persons employed for firefighting activities and rescue activities are clinically healthy.
10. A document for paid state fee to the amount defined by the Council of Ministers.

Documents for a course of initial vocational training at the Academy of MoI or for the period of service at the MoI units shall not be submitted. However, in the list under point 6 information should be included for the year of entering and leaving the MoI units by the person, his/her last job at MoI, period of service in the respective field of activity and year of completion of the course for initial vocational training.

Upon receipt of the application and the file the authorities of the General Fire Safety and Civil Protection Directorate shall examine the completeness and compliance of the documents submitted with the requirements for issuance of permits and, if necessary, shall carry out on-site check of the facilities, the tools and the equipment.

In case of incompleteness and/or discrepancies with the requirements of the law, the authorities of the General Fire Safety and Civil Protection Directorate shall notify the applicant in writing and give instructions and a 30-day period for their removal.

If the deficiencies and/or inconsistencies are not removed within the aforementioned period, the procedure for issuing the authorization shall be terminated.

#### **Issuance / Refusal to issue a permit**

The Director of the General Fire Safety and Civil Protection Directorate or an official authorized thereby issues permit or reasonably refuses to issue such within a period of one month from the submission of the application form.
